# Phase 2A: Arden Service Area Pipe and Meter Installation Project

## **Project Updates**

As of early July, Teichert has installed over 13,000 feet of pipe with the Phase 2A Arden Service Area Pipe and Meter Installation Project (Phase 2A Project). The new water mains were installed along American River Dr., Watt Ave., Hathaway Ct., Callnon Ct., Mering Ct., Sierra Oaks Dr., Lawson Way, Larch Ln., Clemens Way, Ross Way, Bancroft Way, White Oak Ct., Baldwin Way and part of Huntington Rd. At this time, the water main installation is 75% complete (see map attached). Additionally, 40% of the water services have been installed along American River Dr., Watt Ave., Hathaway Ct., Callnon Ct., Mering Ct. and Sierra Oaks Dr. Teichert will continue water main installation heading west on Huntington Rd., Shields Ct. and Burbank Way. Water service installations will continue along Sierra Oaks Dr. and neighboring streets. At this time the water mains remain empty until proper testing, disinfecting and flushing is performed. Similarly, the new service connections from the meter boxes are not connected into the individual homes until we have confirmed the water main has been successfully tested.

- End Construction Expected November 2020
