RESOLUTION ADOPTING THE 2021 SACRAMENTO COUNTY LOCAL HAZARD MITIGATION PLAN UPDATE

WHEREAS, Sacramento County recognizes the threat that natural hazards pose to people and property within our community; and

WHEREAS, undertaking hazard mitigation actions will reduce the potential for harm to people and property from future hazard occurrences; and

WHEREAS, the United States Congress passed the Disaster Mitigation Act of 2000 emphasizing the need for pre-disaster mitigation of potential natural hazards; and

WHEREAS, the Disaster Mitigation Act made available hazard mitigation grants to state and local governments; and

WHEREAS, an adopted Local Hazard Mitigation Plan is required as a condition of future funding for mitigation projects under multiple FEMA pre- and post-disaster mitigation grant programs; and

WHEREAS, Sacramento County fully participated in the FEMA-prescribed mitigation planning process to prepare the 2021 local hazard mitigation plan update; and

WHEREAS, the California Office of Emergency Services and Federal Emergency Management Agency Region IX officials have reviewed the 2021 Sacramento County Local Hazard Mitigation Plan Update (Plan) and approved it contingent upon adoption by the participating governing body; and

WHEREAS, Sacramento County desires to comply with the requirements of the Disaster Mitigation Act and to augment its hazard mitigation and emergency planning efforts by formally adopting the Plan as it is referenced in the Sacramento County Safety Element of the General Plan in accordance with the requirements of California Assembly Bill 2140 (September 29, 2006); and

WHEREAS, adoption demonstrates the commitment of the jurisdiction to pursue the measures in the Plan pursuant to the goals, objectives, and actions; and

WHEREAS, a copy of this adoption resolution will be presented to the California Office of Emergency Services and FEMA Region IX officials to enable the Plan's final approval in accordance with the requirements of the Disaster Mitigation Act of 2000 and to establish conformance with the requirements of California Assembly Bill 2140; and

WHEREAS, Water Resources staff will annually report on the status of the mitigation measures in the Plan.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the Board of Supervisors adopts the Sacramento County Local Hazard Mitigation Plan, dated September 2021.
